07.04.2026	Attendance has been filed on behalf of the petitioner. The instant Misc. Petition u/s- 24 of the C.P.C. has been filed on behalf of the petitioner for call for record of Arbitration case No.-04/2023 from the court of Ld. 03rd D.A.S.J., Purnea for hearing and passing a fresh order. Case called out. Learned counsel for the petitioner appeared on call and submitted that the petitioner has filed an Arbitration R D Case No.-04/2023 against the order passed by the Ld. Commissioner , Purnea Cum Arbitrator in Arbitration Case No.-13/2020 dated-30.03.2022. After admission this case has been transferred to the court of Ld. 3rd D.A.S.J., Purnea which is still pending in said court. The negotiation between the petitioner and O.P. No.-2 and 3 held in the office of the petitioner and proposed amount was sent to the regional office of N.H.A.I., Patna for approval of the proposed amount and on the basis of said approval both parties have jointly filed a compromise petition before the court of Ld. 3rd D.A.S.J., Purnea on 25.02.2026. The lawyers of the both parties as well as O.P. No.-2 and 3 were also present in the said court on date fixed and several times lawyers of both the parties pray for disposal of the case but the court after hearing kept it for order and on just next day it found that no order was passed and the case is fixed for hearing and given a long date i.e. 15.04.2026. Further it is submitted that this project is hampered due to objection of the O.P. No.-2 and 3 and the petitioner want to pay the proposed amount to the O.P. No. 2 and 3 on the basis of settlement. Therefore, prayer has been made to admit this Misc. Petition U/s-24 of C.P.C. and call for record of Arbitration case No.-04/2023 from the court of Ld. 03rd D.A.S.J., Purnea for hearing and passing a fresh order for the end of justice. Heard. Perused the case record and report received from the court of 3rd D.A.S.J., Purnea dated-07.04.2026. From perusal of the same it transpires that the compromise petition on behalf of both parties has been filed on record on 25.02.2026 and thereafter the date of this case has been fixed on 15.04.2026 on dated 26.03.2026 a joint petition on behalf of both parties has been filed and that petition has been permitted and date of this case recalled and fixed for order on 02.04.2026. Due to sad demise of one of the lawyer of bar counsel of Purnea, order of this case could not be passed on 02.04.2026. Next date has been fixed for order on 06.04.2026. coincidentally the order could not be passed on 06.04.2026 due to sad demise of one of the lawyer of bar counsel of Purnea. The date of this case was fixed today i.e. 07.04.2026 for passing order and order of this case has been passed today and Arbitration R.D. Case No.-04/2023 has been disposed. Hence the instant Misc.
