02.07.2026	1. This anticipatory bail application filed on 02.05.2026, on behalf of the petitioner, namely, Mazhar Khalifa @ Mithu @ Md. Majhar, who is apprehending his arrest in connection with Complaint Case No. 901/2021 registered for the offence u/s. 498(A), 504, 506 of IPC is put up for hearing. 2. Heard Sri Kishor Kumar Yadav, learned counsel for the petitioner as well as Sri A.K.Tiwary, learned P.P. appearing for the State assisted by Sri Sanjay Kumar Jha, learned counsel for the complainant. 3. The complaint case filed by the complainant, Shabana Khatoon, in brief, is that her marriage with Mazhar Khalifa @ Mithu @ Md. Majhar (petitioner) was solemnized on 16.02.2010 according to Muslim rituals. It has been alleged that due to inability to provide Rs. 5,00,000/- in cash and a bullet motorcycle as dowry, she was subjected to cruelty by her husband and other in-laws in her matrimonial home. Then complainant's mother and brother went to complainant's in-laws' house and brought the complainant and her three children back to their home. 4. The learned counsel for the petitioner has submitted that the dispute between the complainant and the petitioner has been resolved and both are decided to live together. The	

Contd./ 02.07.2026	petitioner will take care and maintain his wife (complainant) and children as per his financial capacity. There is no criminal history against the petitioner. So, prayed for anticipatory bail. On the other hand, learned P.P. has opposed the prayer of bail of the petitioner. 5. I have heard the rival submission of both parties and perused the original case record. From perusal of the record, it appears that the present case is based on matrimonial dispute and petitioner is the husband of the complainant. There was a dispute in between husband and wife regarding their marital life but now both of them have decided to live together. To resolve the dispute, the record was sent to the Mediation Centre, Purnea on 02.06.2026 and according to the mediation report, the process of mediation was successful between the parties. The complainant appears in the court with her counsel and says that dispute has been resolved between them and good sense has been developed. The petitioner also appears in court and says that he will keep his wife with him with dignity and honour. 6. So, under the facts and circumstances of the case, the prayer for anticipatory bail of petitioner Mazhar Khalifa @ Mithu @ Md. Majhar is allowed. He, in the event of surrender within a fortnight from the date of receipt of this order before the Court below or arrest, shall be released on bail on furnishing bail bond of Rs. 10,000/- (Ten thousand) with two sureties of the like amount each, subject to the conditions as laid down u/s. 438(2) Cr.P.C. The petitioner has to follow all the terms and conditions of the mediation agreement and if found not complying the condition of agreement then learned trial court will be at liberty to
