O R D E R

1. This Criminal Miscellaneous petition has been filed on behalf of petitioner, namely, Moli Kumar Singh @ Molindra Singh with a prayer to correct the typing mistake at paras 6 and 7 in the order dated 11.3.2026 passed by this court in ABP No.375 of 2026 arising out of Supplementary Baisi P.S. Case No.26 of 2023 as in page-2 paras 6 “last line”, it has wrongly been typed as “apprehended accused being own brother-in-law (Shala)” in place of “apprehended accused being son-in-law (Damad)” and in page 3 Para 7 “line 04, it has wrongly been typed as “real owner of the said vehicle, while his brother-in-law (Shala)” in place of “real owner of the said vehicle, while his son-in-law (Damad) and same are apparently a typing mistake and same may be corrected in the said order.

2. The learned counsel has submitted that the prayer of anticipatory bail of the petitioner has already been rejected on merit by this court vide order dated 11.3.2026 passed in ABP No.375 of 2026 and in the said order, in paras 6 and 7, it has wrongly be typed as brother-in-law (Shala) in place of son-in-law (Damad) of the petitioner and the same may be corrected in the said order.

3. The learned P.P. I/c has conceded the submissions put forward on behalf of the learned counsel of the petitioner.

4. Having heard the rival submissions of both the parties and perused the record as well as order dated 11.3.2026 passed by this court in ABP No.375 of 2026 arising out of Suppl.Baisi P.S. Case No.26 of 2023. It appears that the prayer of anticipatory bail of this petitioner has been rejected on merit by this court vide order dated 11.3.2026 passed in ABP No.375 of 2026. In the same order, **in page-2 para 6 “last line”, it has wrongly been typed as “apprehended accused being own brother-in-law (Shala)” in place of apprehended accused being son-in-law (Damad) and in page 3 Para 7 “line 04, it has wrongly been typed as “ real owner of the said vehicle, while his brother-in-law (Shala)” in place of “real owner of the said vehicle, while his son-in-law (Damad)”** and same are apparently a typing mistake. Therefore, the aforesaid typing mistakes in page -2 Para 6 “Last line” **be read as “apprehended accused being owner Son-in-law (Damad)”** in place of “apprehended accused being owner of brother-in-law (Shala)” as well as in page 3 Para 7 “Line 04” **be read as “real owner of the said vehicle,while his son-in-law (Damad)** in place of real owner of the said vehicle,while his brother-in-law (Shala). Office is directed to correct the said typing mistakes in the light of this order in the order dated 11.3.2026 passed by this court in ABP No.375 of 2026 arising out of Suppl. Baisi P.S. Case No.26 of 2023 and send a copy of this order to the learned trial court for information and needful.

Accordingly, the instant Criminal Misc.is allowed.
