O R D E R

1. A bail petition, dated 23-05-2026, supported with an affidavit, has been filed on behalf of the above named petitioner in connection with Cyber Case No. 42/2026, U/s - 318(4), 319(2), 336, 337, 338, 339, 340, 341, 342, 221, 222, 223, 229, 237, 238, 3(5) BNS & 66, 66(C), 66(D), 73, 74 IT Act & 35, 36, 37, 38, 39, 40 Aadhar Act. and was pressed today for hearing by the Ld. Counsel for the petitioner. A copy of petition was also served upon to Ld. Adl. P.P. Heard Sri Kumar Shibanshu, learned counsel appearing on behalf of the petitioner, as well as Sri Rahul Raja, Ld. Addl. P.P. for the State.

2. Brief of the case, as per F.I.R, on 30.04.2026, informant Sanjay Singh, S.I, Cyber police station Purnea got confidential information from Cyber crime unit, Patna. A raiding team was prepared and conducted raid in different cyber cafe of Barhara, Akbarpur, Banmankhi & others for illegal activities for alleged preparing for Rashan Card, Adhar Card, Birth Certificate, Voter ID, PAN Card ,etc.

When informant reached to the shop of Vidya Sagar under Barhara P.S, seeing the police personnel he fled away. Several copies of residential certificate, caste certificate etc were recovered. A HP Company laptop was also recovered and upon enquiry unauthorised site like babartps.xyz, printportal.is were found in browser history. Seizure list was prepared of all the seized articles under videography.

Raid was conducted under Akbarpur P.S at shop of Deepak Kumar who fled away after seeing the police personnel. Several tampered documents as Voter Id, tampered PAN Card and residential certificate were recovered. A HP Company laptop was also recovered and upon enquiry unauthorized site like

babartps.xyz, bestprintportal.co.in, rkbeste.xyz, dashboardorld.in, digitalportal.in were found in browser history. Seizure list was prepared of all the seized articles under videography.

Raid was conducted under Banmankhi P.S at shop of Kundan Kumar Sharman who was working on his laptop in his shop. Upon enquiry it was found that he had cleared his browsing history. Several Aadhar Card and Voter Id were recovered from his possession along with Finger print scanner. Seizure list was prepared of all the seized articles under videography and accused was apprehended and taken to police station.

Raid was conducted under Banmankhi P.S at shop of Vikram Kumar. From the laptop of Vikram Kumar, unauthorized sites as babartps.xyz, workindia.xyz, rtps.expertservice.xyz, printfastportal.co.in, vishalmegamart.shop, ucl24.shop were found in browser history. Several altered aadhar card, voter ID, residential certificate were also recovered. Upon enquiry, Vikram Kumar stated that he used to took loan from bank using these forged documents. Seizure list was prepared of all the seized articles under videography and accused was apprehended and was taken to police station.

Raid was conducted under Banmankhi P.S at shop of Govind Kumar who flee away after seeing the police personnel. A laptop was recovered and upon enquiry unauthorized sites like bestadhaarprint.in, bestprintportal.co.in, bkprint.in, printfastportals.com, skprintportal.in were found in browser history. Several altered PAN card, voter Id card, birth certificates and other government documents were recovered. Seizure list was prepared of all the seized articles under videography.

3. Ld. Counsel on behalf of the petitioner submitted that the petitioner is innocent and committed no offence as alleged. Nothing incriminating has been recovered from the conscious possession of the petitioner. Petitioner signature was absent on the seizure list. The petitioner is a handicap run cyber cafe for his livelihood. Further more there is no one specific who could have been said to be victimized. Petitioner undertakes that he will remain physically present in the Court and is ready to abide by conditions which may be imposed upon him by the Court. The petitioner is ready to furnish local and solvent bailors. Hence, let the petitioner be granted bail.

4. The Ld A.P.P vehemently opposed the prayer of bail and submitted that creating forged document wherein the actions of the applicant are going to impact the national interest, and the security of individual. Therefore the bail petition may kindly be rejected.

5. Heard the rival submissions and Perused. Petitioner did not apprehended on the spot had left the place at the time of raid. Petitioner did not provide any satisfactory answer regarding seized documents as why these

document were kept with him and if these belonged to some one then why not they took their documents and why there is *mismatch in soft and hard copy of the seized document*. No any document regarding authorization of correction / altering of the document was shown which attract section 36,37,38 and 39 of Aadhar Act. In the absence of any authorization regarding running any king of service center attract section 336,340(2),237,238 of BNS. These offence are menace to society which may create rampant ripple in society if granted privilege of bail. This very case is evidently a case of tampering leading to dire consequences. Investigation is still pending. Therefore the chances of tempering with the evidences, if granted bail, cannot be ruled out. In view of the aforesaid fact of the circumstance of the case the prayer of Bail Petition of the petitioner is hereby **rejected** considering the gruesome digital nature of offence
