This anticipatory bail application filed on 02.06.2026, on behalf of the petitioner, namely, Sazid Alam, who is apprehending his arrest in connection with Amour P.S. Case no. 72/2026 registered for the offence u/s. 126(2), 115(2), 85, 118(1), 109, 352, 351(2), 3(5) of B.N.S. is put up for hearing.</p> <p>2. Heard Sri Manish Anand, learned counsel for the petitioner as well as Sri Uday Keshri, learned P.P. I/c appearing for the State.</p> <p>3. The prosecution case in brief is that informant's sister, Dilbari Begam was married approximately ten years ago to Md. Razik according to Muslim customs. His sister has four children. His sister's husband Md. Razik along with his family members used to beat his sister when the dowry demand was not met. He had divorced informant's sister about six months ago, regarding which a Panchayat was held at the social level. During the Panchayat, accused persons accepted their guilt and agreed to take informant's sister back. Meanwhile, on 15.02.2026, under a conspiracy, accused persons together assaulted informant's sister with a stick with the intention to kill her and injured her badly. However, the doctor, seeing her condition as serious, referred her to Purnea Sadar Hospital for better treatment.</p> <p>4. Learned counsel for petitioner has submitted that the petitioner is innocent and he is living another village. He has been falsely implicated in this case due to village politics. There is no criminal history against the petitioner. So, prayed for anticipatory bail.</p> <p>On the other hand, learned P.P. I/c has opposed the prayer of bail of the petitioner.</p> <p>5. I have heard rival submission of both parties and perused the L.C.R. and case diary. From perusal of the same it appears that the petitioner is the brother-in-law of the informant's sister and there is no specific allegation of demanding dowry from informant's sister or assaulting her against the petitioner. After completion of the investigation, I.O. of this case filed chargesheet against the petitioner as not sent up for trial. Cognizance has been taken only against victim's husband Md. Razik (co-accused) under sections 126(2), 115(2), 118(1), 109, 85, 352, 351(2) of BNS. Nothing is mentioned about petitioner's criminal record in the case diary.</p> <p>6. Under the facts and circumstances as discussed above, the prayer for anticipatory bail of the petitioner, namely, Sazid Alam is <b>allowed</b> and it is ordered that in the event of arrest/surrender he will be enlarged on anticipatory bail on furnishing bail bond of Rs.10,000/-(Ten thousand) with two sureties of the</p> |  |
