ORDER

1. A bail petition, dated 04-06-2026, supported with an affidavit, has been filed on behalf of the above named petitioner in connection with Dhamdaha P. S. Case No. 59/2026, U/s - 420,467,468,471,120B/34 of IPC and was pressed today for hearing by the Ld. Counsel for the petitioner. A copy of petition was also served upon to ld. Adl. P.P. Heard Sri Ankit Kumar, learned counsel appearing on behalf of the petitioner, as well as Sri Rahul Raja, Ld. Addl. P.P. for the State.

2. Brief of the case, as per F.I.R, is that in the light of C.W.J.C No. 15459/2014 of Hon'ble High Court, Patna a vigilance team was formed to verify the appointment of employed panchayat teacher. As per investigation, the Marticulation certificate of the petitioner bearing Roll no. 305, Roll code. 64, Father name-Nageshwar Paswan, marks obtained- 511, division- 1st class, D.O.B- 05.03.1985 and passing year 2001 was send for verification to Bihar Sanskrit Education Board. There was mismatch of the certificate detail vis-a-vis the certificate which was produced by the petitioner during the course of appointment. Matriculation certificate bearing same roll no, roll code and passing year but in the name of Rajiv Kumar, Father name- Gajendra Jha, D.O.B 01.08.1985, Marks obtain-330 with second division. F.I.R was registered against the petitioner and other unknown accused.

3. Ld. Counsel on behalf of the petitioner submitted that the petitioner is innocent and committed no offence as alleged and the petitioner did not knowingly use forged document and was unaware of any such said forgery. Petitioner bears clean antecedent and is law abiding citizen. The petitioner surrender voluntary before the Court after knowing about the investigation and

will cooperate in trial and investigation and not temper with the evidence as the educational board holds the original records the petitioner can not interfere neither have access to the the primary evidence. The petitioner is a women and suffering from desease thyroid and high B.P. The petitioner is ready to furnish local and solvent bailors. Hence, let the petitioner be granted bail.

4. The Ld A.P.P opposed the prayer of bail.

5. Heard the rival submission and Perused. Charge sheet has been submitted against the petitioner. Petitioner bears clean antecedent. All the evidence are documentary as alleged which is under strict surveillance under premises of educational board and have no possibility of tampering. The petitioner is in judicial custody since 04.05.2026, suffering from several disease as per submitted document and the petitioner is a lady. Further a copy issued by Rajbati Misrain Sanskrit School has also annexed supporting the contention of the petitioner that at the relevant time she was passed out in First Division itself which fact is under question as per the allegations. In view of the aforesaid facts and circumstances of the case and considering the period of detention in custody as well as the fact that the petitioner is lady with diseases and investigation is completed, the prayer of bail of the accused is hereby ALLOWED and is directed to be enlarged on executing a bond of Rupees 20,000/- (Twenty thousand) with two sureties of like amount each, to the satisfaction of the Ld. Court below with a further condition that one of bail shall be close relative.
