2. No reason has been assigned as to why execution report has not been filed by the concerned SHOs. This court could initiate actions as per the law against the SHOs but not taking that course of action, this court wish to give one chance to the SHOs before initiating action against them as per the law.

3. SHOs are directed to file the execution report positively by next date failing which this court shall order for deduction of Rs. 500/- per day from the salary of concerned SHOs. This is a caution to all the concerned SHOs.

4. Let one copy of order be sent to all the SHOs who are directed to execute the Non Bailable warrant.

5. **Let one copy of order be sent to S.P., Rohtas to direct the SHOs under the control of him to comply and execute the NBWs. Let one copy be also sent to S.P., Arwal because one of the accused persons is from Mehendiya P.S.**

6. Put up all these records on 24.08.2026 for receipt of execution report/appearance.
