Petition dated 08.08.2026 U/s.483 BNSS to grant bail to the petitioner.

This petition is coming on this day for hearing before this court in the presence of **Thiru.S.Pasumpon Selvakumar**, Advocate for the Petitioner and **Thiru.A.Arun**, Public Prosecutor for the Respondent/complainant and upon hearing both sides, this Court passed the following :

ORDER

The Petitioner/accused was arrested and remanded to judicial custody on 06.08.2026 for the alleged offences punishable under sections 6, 5(1) of POCSO Act registered by the respondent police, seeks bail.

The learned Counsel for the petitioner/accused would submit that due to non appearance of this petitioner on 09.07.2026 NBW was issued and he was secured on 06.08.2026 and due to his illhealth, he was not able to attend the court and this case was charge sheeted and numbered as Spl.S.C.45/2026 and pending before this court and this petitioner is undergoing incarceration for the past 6 days and prays to grant bail to the petitioner subject to any conditions.

The learned Public Prosecutor would submit that it is a case of jumped out of

bail and NBW issued on 09.07.2026 and this petitioner was secured on 06.08.2026 and this case was charge sheeted and numbered as Spl.S.C.45/2026 and pending before this court and due to non appearance of this petitioner the case is pending for a long period.

Heard. Records perused. The submissions of both sides were considered. The allegation is that it is a case of jumped out of bail and due to non appearance of this petitioner on 09.07.2026 NBW was issued and this petitioner was secured by the respondent. Considering the fact that the petitioner is in custody for the past 6 days and this case was charge sheeted and numbered as Spl.S.C.45/2026 and pending before this court and other facts and circumstances, this court is inclined to grant bail to the petitioner/accused.

In the result this petition is allowed subject to following conditions.

- i) The petitioner is ordered to be enlarged on bail on executing his bond for Rs.10,000/- (Rupees Ten Thousand only) with two sureties for a like sum each to the satisfaction of this court.
- ii) The sureties shall affix their photographs and Left Thumb Impression in the surety bond and the sureties shall produce a copy of their Aadhaar card or Solvency Certificate or Bank pass book to ensure their identity.
- iii) **The petitioner is directed to appear before this court as and when directed by this court.**
- iv) **The Petitioner has to furnish his Mail ID and Phone number before this court at the time of executing bond.**
- v) The petitioner shall make available himself for interrogation as and when required by the investigation Officer.
- vi) The petitioner shall not tamper the witness or hamper the evidence in any manner either during investigation or Trial.
- vii) The petitioner shall not abscond either during investigation or Trial.
- viii) That on breach of any of the aforesaid conditions, the Investigation Officer shall report to the learned Magistrate / Trial Court and shall take appropriate action against the petitioner in accordance with law.
- ix) If the accused thereafter absconds, a fresh FIR can be registered U/S.269 BNS.
