<u>23/01/2023</u>	Non FIR u/s 37 of the Bihar Prohibition & Excise Act-2016 has been received from <u>Dharampura (D.P.)</u> Police Station District- Rohtas. Register it. I.O. has forwarded the accused namely, <u>Chunesh Kumar Rai</u> <u>Aged- 30 years, S/o- Chish Naryan Rai, R/o- Dharam-</u> <u>-Pura, P.S- Nokha (Dharampura) D.P. Dist- Rohtas.</u> u/s 37 Bihar Prohibition & Excise Act-2016 with enquiry report in Form VI, forwarding report, arrest memo, corona (-ve) report, liquor consumption report and under proper police escort party. On being asked accused does not complain any ill-treatment by the police. Perused the enquiry report and other documents submitted by the police/excise officer. I hereby take cognizance under section 37 of Bihar Prohibition and Excise Act, 2016 against the above named all the accused persons. The charge against the accused is that the accused had consumed alcohol on <u>23/01/23</u> and was caught at <u>Dharampura</u> and he was subjected to medical examination/breath analysis test which confirmed that the above named accused had consumed alcohol/liquor and in the breath analyser test <u>191-mg/100ml.</u> alcohol has been found in the breath of above named accused. The above charge is read out and explained to the accused. I have recorded his/their deposition. The accused is asked to state whether he/they pleads guilty. The accused plead guilty. I am prima facie satisfied that the charge against him/them is well founded. The accused is/are therefore sentenced to pay a sum of ₹ <u>3000</u> /- (Rupees <u>Three Thousand</u> only) or in default of payment of the said amount to undergo simple imprisonment for 30 days under Section 37 of Bihar Prohibition and Excise Act, 2016. 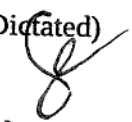
