|                        | 16.01.2026    | <p>Attendance has been filed on behalf of the complainant through her counsel. Record has been put up for orders after hearing on the point of summoning the accused persons.</p> <p>This complaint case has been filed by Pratibha Devi against Satyendra Dubey, Krishna Mohan Dubey, Devendra Dubey, Lakhan Yadav, Sunil Yadav, Anil Yadav and Vakil Yadav, for the offences punishable under Sections 147, 148, 323, 341, 379, 354, 504, and 506 of the IPC and under Section 27 of the Arms Act</p> <p>The case of the complainant, as alleged in the complaint petition, is that she is the owner of a plot of land situated at village Gursaut, bearing Khata No. 19, Plot No. 291, measuring 2.50 decimals, and that she has been in peaceful possession thereof since long. It has further been stated that she had cultivated a wheat crop on the said land, which was ripe and ready for harvesting. It has further been alleged that on the date of the occurrence, all the accused persons came to the said land armed with weapons and forcibly started harvesting the wheat crop. Upon receiving information from the witnesses, the complainant went to the place of occurrence and forbade the accused persons from harvesting the crop. Thereupon, the accused persons became aggressive, abused her in filthy language, and assaulted her. It has further been alleged that the accused persons surrounded her and continued to beat her, and that one of the accused persons, namely Krishna Mohan Dubey, outraged her modesty by inserting his hand into her blouse and catching her breast. It has also been alleged that the accused persons threatened her husband with dire consequences, stating that they would be shot dead if they did not flee from the place of occurrence. It has further been alleged that the value of the harvested wheat crop was approximately ₹25,000/- and that the accused persons forcibly harvested and took away the entire crop.</p> <p>The statement of the complainant was recorded under section 200 CrPC, in which she has supported the allegations levelled by her in the complaint petition. An inquiry was also conducted in the matter in which the</p> |                                                            |

complainant has examined four witnesses on her behalf who have supported the contentions of the complainant.

Heard the Ld. Counsel for the Complainant and perused the record.

On hearing the learned counsel for the complainant and upon perusal of the complaint petition, the statement of the complainant on solemn affirmation, the inquiry conducted in the matter, this court finds that there are sufficient materials on record to proceed against all the accused persons for the offences punishable under Sections 147, 148, 323, 341, 379, 354, 504, and 506 of the Indian Penal Code.

Accordingly, O/c is directed to issue summons against the above-named accused persons upon filing of requisites and process fees by the complainant. The complainant is directed to file the requisites for summons and process fees, as required for issuance of summons within 14 days from the date of this order.
