| 01/08/2026                   | <p>Heard both sides on the regular bail application of the juvenile in conflict with law namely <b>Babul Kumar</b> who is in judicial custody since 17.11.2025. It is submitted on behalf of the appellant that the name of the petitioner came in this case only on the basis of suspicion. No any persons has seen this persons committing the crime as alleged in the FIR. It is further submitted that the the age of the petitioner within 16 years, hence prayer is made to enlarge the petitioner on bail.</p> <p>The ld. A.P.P opposed the prayer of bail.</p> <p>Having heard both sides, perused the case record and found that one Kanchan Devi has alleged that due to quarrel between his son Sumesh Kumar and Babul Kumar some altercation has taken place earlier in between both the families and it was threatened by the family of the accused that he will kill his son. It is further alleged that on 08.09.2025 at about 9:00 PM his son had went out from his house on call of unknown person and did not return till late night. On the next date the dead body of her son was found and there was suspicion that the present petitioner along with Rajbir Kumar have committed murder of Sumesh Kumar “the son of the informant”. Investigation has already been completed in this case and charge sheet has been submitted. From perusal of the charge sheet it appears that the petitioner was not associates of any criminals. The ld. A.P.P did not argue on the point that if he will be released on bail, he will fall into association of any known criminal or Psychological and moral danger may caused to him. More so, the statutory grounds of rejection of bail application of the juvenile as mentioned in section 12 of the JJB Act did not present in this case.</p> |                               |
