Heard Learned PP and the acccused persons under section 232 of CrPC.</p> <p>6. The Learned PP fairly submitted that it is a case of no evidence. All the five witnesses examined in the case have not supported the case of prosecution. The submission of the Learned PP considered. Record perused.</p> <p>7. PW-1 Tuntun Sharma, PW-2 Shiblu Sharma, PW-3 Ram Pravesh Sharma PW-4 Ravindra Sharma have turned completely hostile and nothing stated incriminating against the accused persons. PW-5 Ajay Kumar Sharma has barely identified his signature on the inquest of the deceased and has stated that the police has prepared inquest report in his presence.</p> <p>8. In the cross examination of PW-5 has stated that police has obtained his signatures on blank paper and no inquest proceedings in his presence was prepared. Even otherwise the inquest proceedings is not a substantive piece of evidence. There is absolutely no evidence against the accused persons. Therefore, both the accused persons namely Prakash Sharma and Akali Devi are hereby acquitted from all the charges framed against them. They have not furnish bail bonds in terms of section 437A of Cr.PC/481 of the BNSS.</p> |                               |
