Late Bhikho Ray, (13) **Babloo Ray @ Babloo Kumar** S/o Late Ramdev Ray who are apprehending their arrest in connection with Darhar P.S. Case No. 17/2026 registered under Sections 181(2), 192(2), 126(2), 115(2), 117(2), 118(1), 109, 352, 351(2)(3), 303(2) of BNS, 2023.

2. Heard the arguments of the learned counsel for the petitioners and the learned P.P. for the State.

3. It is submitted by the learned counsel for the accused petitioners that petitioners are innocent and have falsely been implicated in this case. Further submitted that S.T. Case No. 49/2026 is pending against the petitioners Satto Ray, Lalan Ray, Bhudev Ray, Roushan Ray, Dhruv Ray and Gopal Ray and S.T. Case No. 139/2022 is pending against the petitioners Satto Ray, Bhudev Ray, Roushan Ray, Dhruv Ray and S.T. Case No. 317/2022 is pending against the petitioners Satto Ray and Bhudev Ray and in all the cases the petitioners are on bail whereas petitioner nos. 3, 4, 5, 6 10 and 12 bears no criminal antecedent. It is further submitted that there is case and counter case between the parties. It is further submitted that Sections 118(1), 109, 303(2) of BNS, 2023 are added to make the case graver and non-bailable. It is further submitted that petitioners are men of means and there is no chance of their absconding or tampering with the evidence in this case and they are ready to furnish sound sureties to the full satisfaction of the court. Upon these grounds, the learned counsel prays to grant anticipatory bail to the petitioners.

4. On the other hand, the learned P.P. has opposed the prayer of anticipatory bail of the petitioners.

5. Rival submissions considered, Record perused.

6. The case of the prosecution in brief, is that as per the written report of informant Umesh Ray is that on 03.03.2026 at about 04:00 O'clock he slept at his house

then Bhudev Ray, Roushan Ray, Dhruv Ray, Sato Ray, Baban Ray, Ajay Ray, Banbir Ray, Gopal Ray, Sunil Ray, Anil Ray, Ranjan Ray, Devendra Ray, Bablu Ray and Lalan Ray due to prior enmity all armed with deadly weapons with prior enmity came there and assaulted with filthy words. When he objected then Bhudev Ray armed with Farsa in his hand assaulted on his head due to which he sustained injury due to which he fell down on the ground. When his brother Vinit Kumar and co-villager Sanjay Kumar came to rescue him then the accused persons also assaulted them. The accused persons also pelted stones on his house due to which his other family members were injured. Lala Rai snatched gold chain and gold ring from him. On hearing hulla the nearby people came there and pacified the matter.

7. A case being Darhar P.S. Case No. 16/2026 for the alleged commission of offence under Sections 191(2), 191(3), 126(2), 115(2), 118(1), 117(2), 109, 352, 352(2)(3), 3(5) of BNS, 2023 has been lodged by one of the petitioner Anil Ray against the informant side. All the injured has suffered simple injuries. Some of which on the vital part of the boy. However the injuries which are on the vital part of the body are simple in nature. The grievous injuries are on right hand middle finger of injured Umesh Rai another grievous injury is on the person of injured Krishna Mohan Rai which is lacerated wound of size 0.5x0.5x0.5 cm over Rt. Hand middle finger and swelling over right hand. Fracture was found at base of 2nd metacarpal bone. Fracture was also noted at the base of proximal phalanx of index and middle finger.

Considering the fact that there is a counter version also and further considering the nature of injury, the prayer for anticipatory bail of petitioners (1) **Anil Ray**, (2) **Sunil Ray**, (3) **Satto Ray**, (4) **Bhudev Ray** (5) **Roushan Ray**, (6) **Dhruv Ray**, (7) **Baban Ray @ Baban Kumar Ray**, (8) **Banbir Ray @**
