Upon these grounds, the learned counsel prays to grant bail to the petitioner.</p> <p>4. On the other hand, the learned P.P. has vehemently opposed the prayer of bail.</p> <p>5. Rival submissions considered, Record perused.</p> <p>6. The prosecution case, in short as per the typed report of informant Probationer PSI Raja Kumar is that on 25.04.2026 he alongwith armed force on secret information proceeded for conducting raid and when he reached at Dumra then a person tried to flee away from there after seeing the police but with the help of police team he was apprehended and on query he disclosed his name as Akhilesh Thakur. During search a countrymade pistol was recovered from the terrace of his house. Thereafter seizure list was prepared and a copy of which was handed over to the apprehended accused. Thereafter the accused was arrested and brought to police station alongwith seized article.</p> <p>7. The petitioner is in custody since 26.04.2026 having clean past antecedent as mentioned in para 24 of the case diary. The countrymade pistol has been recovered from the house of the petitioner which is stated to be joint house. The investigation is almost complete and for further investigation the custody of the petitioner is not required.</p> <p>8. Considering the facts and circumstances of the case, a case to grant bail to the petitioner accused namely Akhilesh Thakur is made out. Resultantly the prayer for bail is <b>allowed</b>.
