Today the case was fixed for Order.

Ld. APP is present for the prosecution.

All the 04 (four) accused persons namely 1. Sri Rajib Kr. Sarkar @ Raju, 2. Sri Haralal Sarkar, 3. Sri Shibu Debnath and 4. Sri Dipak Sarkar are present along with their Ld. Engaged Counsel Mr. G. Ghosh.

Ld. Defence Counsel Mr. G. Ghosh and Ld. APP for the prosecution has filed a joint compromise petition U/s 320(i) of Cr.P.C. through the complainant of this case namely Sri Biplab Sarkar and all the above named 04 (four) accused persons.

Perused the record.

On scrutiny of the record, I find that the instant case involves Offences U/Ss 341/323/448/427/34 of IPC which are compoundable in nature.

Accordingly, the complainant namely Sri Biplab Sarkar appeared before the Court and verbally submitted that the case has been amicably settled between the parties outside the Court and has satisfied the Court that he has compromised this Case voluntarily without any pressure, threat, coercion or undue influence from any corner.

Heard Ld. APP as well as Ld. Defence Counsel for the accused person.

Also perused the compromise petition.

Tag it with the case record.

In light of the above, I am satisfied with the submissions of Ld. APP as well as Ld. Defence Counsel on behalf of the accused persons and the Offence alleged in this case U/Ss 341/323/448/427/34 of IPC being compoundable in nature. The petition filed for compromise U/S 320(i) of Cr.P.C. of the case on behalf of the complainant is hereby allowed.

Accused persons namely 1. Sri Rajib Kr. Sarkar @ Raju, 2. Sri Haralal Sarkar, 3. Sri Shibu Debnath and 4. Sri Dipak Sarkar are acquitted of the Offence alleged against them U/Ss 341/323/448/427/34 of IPC and are set at liberty forthwith.

Hence, the case is, thus, disposed of on compromise.

The surety of the accused if any, is discharged from the liability of the bail bond.
