A withdrawal petition supported by an affidavit has been filed on behalf of appellants for withdrawal of this Title Appeal.

On call Ld. lawyer of appellant appeared in court and pressed the aforesaid withdrawal petition. It has been submitted that this present appeal was filed against the judgment and decree dated 25.09.25 passed by the Ld. Sub Judge-1st, Rosera (Samastipur) but now the well-wishes of both the parties have brought about a settlement between the parties, due to which all the disputes between the parties have now ended. Further that the appellants accept the judgment passed by the learned Sub Judge-1st, Rosera

and do not seek to have it vacated. The appellants waive all claims to the disputed land, and the appellants or their heirs will have no claim in the present or future. The respondent's possession of the land will remain intact. The appellants are voluntarily and knowingly withdrawing this appeal. Hence, prayed to allow the withdrawal petition and dismiss the appeal.
