Heard, Sri Barun Chandra Kuwar , Ld. Counsel for the accused petitioners and Sri Sita Ram Yadav , Ld. Addl.P.P. for the state , on a bail petition filed on behalf of accused 1. Ritesh Singh alias Ritesh Kumar Singh and 2. Rupesh Singh alias Rupesh Kumar Singh ,who apprehend his arrest in connection with Singhiya P.S. Case No. 253 of 2025 , U/s 115(2),126(2),127(2),109,117(2),190,191(2), 303(2),271,272,351(2) B.N.S. , pending in the Court of Sri Jeetendra Kumar , J.M.,Ist Class, , Rosera .

Ld. counsel for the accused petitioners has submitted that petitioners are innocent and have committed no offence but they have falsely been implicated in this case due to land dispute enmity . It has further been submitted that petitioner has got one criminal history. It has further been submitted that informant Mantosh Jha is brother of victim Santosh Jha and informant has no eye witness of the occurrence . It has further been submitted that all allegations levelled in F.I.R. against the petitioners are false ,baseless . It has further been submitted that there is several cases is pending in between the parties . So,he prays to enlarge the accused petitioners on anticipatory bail.

On the other hand Ld. Addl.P.P. on behalf of state opposed the prayer for bail .

The prosecution case in brief is that informant Mantosh Jha filed an written petition before the concerned O.C.,P.S. ,stating therein that on 11.12.2025 at 12.30 P.M. when his brother Santosh Jha was going to Indian Gas Agency ,and in the way this petitioner along with other, named in the F.I.R. surrounded his brother and assaulted to him badly by means of iron rod ,Lathi, butt of rifle ,due to which he sustained grievous injury ,and accused persons also loaded to his brother in a car and took away to him another place ,and there they were assaulted to him ,due to which

16.03.2026 his bone fractured ,and also snatched his golden chain and golden ring ,and also pour
urinal in the mouth of his brother . And later on he was treated in P.H.C. ,Singhiya .

From perusal of the photocopy of case diary,it transpires that the informant
as well as other witnesses have supported the case of prosecution vide para 2,7,8,9 of
the case diary. From perusal of para 79 ofthe case diary ,it transpires that injury
found on the injured Santosh Jha is grievous in nature ,and case is pending for
investigation .

So, considering the aforesaid facts and circumstances as mentioned above as
well as nature of offence , I am not inclined to enlarge the accused petitioners on
anticipatory bail. Accordingly, anticipatory bail petition filed on behalf of aforesaid
accused petitioner is here by rejected .
