**ORDER**

Heard the counsel for the plaintiff/petitioner. No caveat is reportedly pending. Perused the records. The accompanying affidavit discloses prima facie case. I am satisfied that if the notice is issued before granting the injunction, the resultant delay would defeat the purpose of granting the injunction. Further I believe that if injunction is not granted irreparable injury will be caused to the plaintiff/petitioner.

Hence, the respondents or anyone acting under them are restrained from committing the acts of waste in the plaint schedule property and from inducting strangers therein until further orders. Comply with Proviso (a) and (b) to Order 39 Rule 3. Issue notice to the respondents. Return of notice by 07.04.2026
