Suit Claim : This suit was filed on **2.8.2025** by the plaintiff
and prays to judgment and decree:

- (a) Directing the defendants jointly and severally to pay
a sum of Rs.2,34,188/- (Rupees Two Lakhs Thirty
Four Thousand One Hundred Eighty Eight Only) to
the plaintiff towards the value of goods supplied.

- (b) Award interest at the rate of 24% per annum on the sum of Rs.2,34,188/- (Rupees Two Lakhs Thirty Four Thousand One Hundred Eighty Eight Only) from the date of default till the date of realization.
- (c) Direct the defendants to pay a sum of Rs.5,000/- (Rupees Five Thousand Only) towards notice charges,
- (d) Award the costs of the suit and proceedings, and
- (e) Grant such other and further reliefs.

This suit coming on this day for final disposal before **Sri. Nandeesh.R.P., XXII Additional City Civil and Sessions Judge, Bengaluru City**, in the presence of Sri. S.Madhu - Advocate for the Plaintiff and of Defendants - Exparte.

It is ordered and decreed that the suit of the plaintiff is decreed with costs.

It is further ordered and decreed that the defendant Nos.1 and 2 are jointly and severally liable to pay suit claim amount of Rs.2,34,188/- (Rupees Two Lakhs Thirty Four Thousand One Hundred Eighty Eight Only) with interest at the rate of 18% per annum from the date of the suit till realization of entire amount.

It is further ordered and decreed that the the defendant Nos.1 and 2 are directed to pay the suit claim amount with interest within 3 months from the date of the decree.

And that a sum of Rs.19,348/- be paid by the Defendant/s to the Plaintiff/s on account of costs of the suit.
