	<p><b><u>12-03-2026</u></b> <b><u>Contd.</u></b></p>	<p><b>countrymade liquor was recovered from the spot</b> which was duly seized and prepared seizure list in presence of two witnesses from raiding party.</p> <p>Perused the case record. From perusal of record, it further transpires that on secret information, in course of raid by the informant and police personnel near Fulchak Chirand Pokhari, where on seeing the police jeep, one person fled away from the spot. On searching, the police recovered total 40 litres of illicit countrymade liquor from the spot. Upon inquiry, the local people disclosed the name of fled person as <b>Sanjay Manjhi (petitioner here)</b>. Thereafter, police seized the illicit liquor and prepared seizure list in the presence of two witnesses from raiding party.</p> <p>As such, considering prima facie accusation against the petitioner, anticipatory bail petition is not maintainable in view of Sec. 76(2) of Bihar Prohibition &amp; Excise Act.
