Case No. 39/2021 and petitioners no. 2 & 3 have no criminal antecedents as stated in para-03 of the anticipatory bail petition. Seized articles have not been recovered from the possession of these petitioners. Hence, he prays for anticipatory bail.</p> <p>On the other hand, the ld. Special P.P.(Excise) opposed the bail.</p> <p>Prosecution story, in brief, is that total 134.200 litres of illicit foreign liquor was recovered from semi-constructed room near Daftarpur School which was duly seized and prepared seizure list in presence of two witnesses from raiding party.</p> <p>Perused the case record. From perusal of record, it further transpires that on secret information, in course of raid by the informant and police personnel near Daftarpur School in Vill-Daftarpur, where on seeing the police jeep, three persons fled away from the spot. On searching, the police recovered total 134.200 litres of illicit foreign liquor from semi-constructed room near Daftarpur School. Upon inquiry, the local people disclosed the name of fled persons as Vinayak Pratap Singh @ Tarzan, Suman Kumar, Mrityunjay Singh & Raftar Singh @ Bholra respectively. Thereafter, police seized the illicit liquor and prepared seizure list in the presence of two witnesses from raiding party.</p> <p>As such, considering prima facie accusation against the petitioners, anticipatory bail petition is not maintainable in view of Sec. 76(2) of Bihar Prohibition & Excise Act. Accordingly, this anticipatory bail petition of petitioners namely (1) <u>Vinayak Pratap Singh @ Tarzan</u> (2) <u>Suman Kumar</u> & (3) <u>Raftar Singh @ Bholra @ Rohit Kumar</u> stands <i>rejected</i>.</p> <p style="text-align: right;">Dictated</p> <p style="text-align: right;">(PREETAM KUMAR RATAN) Addl.
