**ORDER**

**07/04/2026**

This bail petition is filed on behalf of accused namely, Raktu Mahto, in connection with Pahaleja P.S case No. 123/25 registered under Sections 126(2), 115(2) 109(1), 303(2), 351(2), 352, 3(5) B.N.S.

Learned advocate on behalf of petitioner submits that accused is innocent and has been falsely implicated and that the petitioner has no criminal antecedent and is in custody since 21/01/2026. It is prayed to release the accused on bail.

Learned Additional P.P opposed the bail of the petitioner.

Heard both parties. In brief, this prosecution case is registered on the basis of fardbeyan of informant namely, Murti Devi, wherein, it is stated that on 25/10/2025, at around, 08:00 PM, all accused persons started abusing the informant's father-in-law & assaulted him. When the informant objected, she was also assaulted, thereby, injuring her on head. Accordingly, this case is registered under Sections 126(2), 115(2) 109(1), 303(2), 351(2), 352, 3(5) B.N.S.

From perusal of para 5 of case diary containing re-statement of informant, para 6, 7, 8, 9 of case diary containing statement of other witnesses, it transpires that there is general & omnibus allegation of assault on the accused petitioner. From perusal of injury report, it transpires that Murti Devi injury on occipital region is simple in nature. There is no repetition of blow. Charge-sheet has been submitted against the accused petitioner & he is in custody since 21/01/2026.

Considering general & omnibus allegation of assault, custody period already undergone by the accused, and also for reasons mentioned above, I am inclined to
