30.03.2026.	<p>This anticipatory bail petition has been filed on behalf of the petitioner namely, Pradip Sah who is apprehending his arrest in connection with Suppi PS Case No.52/26 registered u/ss: 103,61(2), BNS and 27 Arms Act.</p> <p>2. Heard the learned counsel for the petitioner and the learned I/C PP for the State.</p> <p>3. It is submitted by the learned counsel for the petitioner the petitioner is quite innocent and has falsely been implicated in this case. All the allegations levelled against the petitioner are false and baseless.Nothing incriminating material has been recovered from possession of the petitioner. The petitioner has no criminal antecedent. On these grounds, the learned counsel prayed to grant anticipatory bail to the petitioner.</p> <p>4. On the other hand, the learned I/C PP has opposed the prayer for bail.</p> <p>5. Rival submissions considered. Record perused.</p> <p>6. The prosecution case, in short, as per written application of the informant namely, Ravindra Sah is that on 8.2.2026 the petitioner alongwith other co-accused persons due to enmity committed murder of his son namely, Roshan Kumar by shooting out while he had gone in Barat in Ramnagra village.</p>



7. The petitioner is specifically named in the FIR having allegation of committing murder of son of the informant namely, Roshan Kumar by shooting out due to previous enmity with association with criminal elements. Investigation of the case is still going on.

Considering the aforesaid facts & circumstances of the case, serious nature of offence, involvement of the petitioner in the alleged commission of offence and stage of investigation, this Court is not inclined to grant anticipatory bail to the petitioner. Accordingly, the instant anticipatory bail application is hereby rejected. The petitioner may surrender and seeks regular bail which shall be disposed of by the learned Court without being prejudiced by this order.
