<u>19.06.2026.</u>	This bail petition has been filed on behalf of the petitioner namely, Gulab Nadaf who is in custody since 08.05.2026 in connection with Sursand PS Case No. 242/24 registered u/s: 395 IPC. 2. Heard the learned counsel for the petitioner and the learned I/C PP for the State. 3. The learned counsel for the petitioner submitted that the petitioner is innocent and has falsely been implicated in this case on the alleged confessional statement of other co-accused, Amit Kumar, which has no evidentiary value. Nothing incriminating material has been recovered from possession of the petitioner. No TIP was conducted in this case. The petitioner has criminal antecedent of four cases. Other co-accused persons with similar allegation have been granted bail vide BP No. 1285/24,1389/24,305/25,603/25,572/25, 1268/25. and 125/26 .On these grounds, the learned counsel prayed for grant of bail to the petitioner. 4. The learned I/C PP submitted that although the petitioner is not named in the FIR, but his name surfaced in confessional statement of other co-accused Amit Kumar. However, the learned I/C PP fairly conceded that other co-

<u>Contd.</u> <u>19.06.2026.</u>	accused persons have been granted bail and except confessional statement of co-accused there is no any incriminating material against petitioner. 5. The prosecution case, in short, as per Fard-beyan of the informant namely, Rajesh Kumar is that in the night of 22.5.2024 at 2.30 hours 12 miscreants confined the informant and his family members in a room on the point of countrymade pistol and committed dcoity of ornaments, cash and documents of land etc. 6. Perusal of record shows that the petitioner is not named in the FIR. There is no recovery of any incriminating article from his possession. Name of this petitioner surfaced in this case in the confessional statement of co-accused Amit Kumar. Petitioner has been remanded in this case from Sursand PS Case No. 47/25. No TIP has been conducted in the case. Except confessional statement of co-accused Amit Kumar whereby he allegedly disclosed name of petitioner, no any other incriminating material has been placed on record by prosecution against petitioner. The petitioner is in custody since 08.05.2026. Investigation against the petitioner is complete and charge-sheet has already been filed. Other Similarly placed co-accused persons have been granted bail vide BP No. 1285/24,1389/24,305/25,603/25,572/25,1268/25 by learned predecessor of this Court and vide BP No. 125/26 by this Court. 8. Considering the aforesaid facts & circumstances of the case , bail of the petitioner is allowed. The petitioner is directed to be released on bail on furnishing bail bonds of Rs. 10,000/-(Ten Thousand) with two sureties of the like amount each to the satisfaction of the Court where the case
