<u>25.08.2026.</u>	Apprehending arrest this anticipatory bail petition has been filed on behalf of the petitioner namely, Kamlesh Kumar, in connection with Chorout PS Case No. 121/26 registered u/ss: 125 BNS and 25(9) Arms Act. 2. Heard the learned counsel for the petitioner and the learned I/C Special PP for the State. 3. Learned counsel for the petitioner submitted that the petitioner is quite innocent and he has falsely been implicated in this case. All the allegations levelled against the petitioner are false and baseless. The petitioner has no criminal antecedent. On these grounds, the learned counsel for petitioner prayed for grant of anticipatory bail to the petitioners. 4. On the other hand, the learned I/C PP submitted that the instant anticipatory bail petition is not maintainable as the offences in which the instant case has been registered are bailable in nature. 5. Perusal of record shows that the instant anticipatory bail petition has been filed u/ss: 125 BNS and 25(9) Arms Act, which are bailable in nature. Apprehension of arrest is the sine-qua-non for maintainability of anticipatory bail petition. 6.
