Amar Kumar Das, for the State.</p> <p>By this order we are going to dispose off the anticipatory bail application filed on behalf of accused/ petitioner, namely Upas Kumar @ Ramchandra Kumar, who is apprehending his arrest in connection with Raghopur PS Case No.:- 36/26, u/s- 96 of B.N.S.</p> <p>Ld. counsel for the accused/ petitioner argued that accused/ petitioner is quite innocent and has committed no crime and he has falsely been implicated in this case due to local village politics. He further submitted that accused/ petitioner have not involving in any other case and having the clean antecedent. He further submitted that the offence as alleged in FIR is not applicable against the accused/petitioner. It is also submitted that accused/ petitioner is ready to abide by the provisions of section 482 of B.N.S.S, so he may be admitted to the anticipatory bail.</p> <p>Ld. APP for the State strongly opposed the anticipatory bail application.</p> <p>In brief, the prosecution story is that a written application was given by the informant namely Manju Devi to the police of PS Raghopur, stating therein that the accused Upash Kumar has kidnapped her daughter, aged about 17 years. The informant further alleged that the accused persons namely Meena Kumari, Tunur Sharma, Anshu Kumari, Ratani Devi, Juli Devi, Bahadur Sharma, Basant Kumar Sharma, Shiv Kumar Sharma and Lalit Sharma have assisted the accused Upash Kumar in taking away the daughter of informant. Thereafter, the informant tried to search her daughter, but she has not been recovered so far.</p> <p>Argument heard from both sides and perused the record as well as case diary. On going through the case diary, it transpires that the police also recorded the statement of the witnesses namely Kanhaiya Kumar and Nitish Kumar and they have duly supported the prosecution case. As per para No.55 of the case diary, the date of birth of the victim girl is 11.04.2008. This offence was committed on 30.01.2026. Though in her statement, the victim girl has not made any allegation against this accused/ petitioner, but since the victim girl was minor on the day of the commission of the crime. Hence, undue force and inducement also cannot be ruled out and for the just conclusion of the investigation, this accused/ petitioner must be duly interrogated. The allegation against this accused/ petitioner is very serious in nature. The investigation of this case is in primary stage. Tempering of the prosecution evidence by this accused/ petitioner is also cannot be ruled out.</p> <p>Hence, keeping in mind the seriousness of the allegation, I find that the accused/ petitioner is not entitled to get the benefit of anticipatory bail.
