ORDER

25.03.2026

1. The present bail application has been filed on behalf of the accused-petitioner namely **(1) Akash Sharma**, who is in judicial custody since 02.03.2026 in connection with Darauli P.S Case No. 115/2026 registered u/s 126(2), 76, 109, 351(2) & 61(2) of BNS.

2. Ld. Counsel of the petitioner submits that the petitioner is innocent and has committed no offence, rather he has falsely been implicated in this case. The petitioner has got no criminal antecedent. Ld. Counsel further submits that there is no allegation as alleged in the FIR is made out against the petitioner. Petitioner is in judicial custody since 03.03.2026. There is no chance of his absconding or tampering with the prosecution evidence. Hence, learned counsel prays for bail.

3. On the other hand, Ld. P.P opposes the prayer of bail.

4. Heard. Perused the record.

5. From perusal of the record, it transpires that an FIR vide Darauli P.S Case No. 115/2026 was registered on 02.03.2026 u/s 126(2), 76, 109, 351(2) & 61(2) of BNS against the petitioner along with other co-accused persons. As per FIR, the informant alleged that during the Vishnu Mahayagya at village-Balia, Riyaz Ansari, Bhim Kharwar, Ravi Kharwar, Akshay Kharwar, Nitesh Yadav and other 5-6 unknown persons misbehaved with women and girls. When the informant protested, all the accused persons committed marput with him. Thereafter, when the informant had come to Darauli for his necessary work, all the accused persons attacked to informant with iron rod, fighter, gupti and danda, as the result, the informant sustained injury on his hand and shoulder.

6. From perusal of record, it appears that there is only allegation against the petitioner to instigate the co-accused persons except this there is no any allegation attributed against the petitioner. Moreover, petitioner is in custody since 02.03.2026.
