ORDER

1. Ld. Counsel moves this anticipatory bail petition on behalf of accused petitioner namely **Rita Kumari**, who apprehends her arrest in connection with Darauli P.S. Case No. 136/2026 registered u/s 406, 467, 468, 471, 120(B) 420, 120(B) of IPC.

2. Ld. Counsel for the petitioner submits that petitioner is innocent and has committed no offence, rather she has falsely been implicated in this case. The allegations as narrated in the FIR is totally false, baseless and concocted. Petitioner bears no criminal antecedent. Ld. Counsel further submits that petitioner is a lady and suffering from economical problems. There is no chance of her absconding and tampering with the evidence. Hence, Ld. Counsel prays for anticipatory bail.

3. On the other hand, Ld. P.P opposes the prayer for anticipatory bail.

4. Heard. Perused the record.

5. From perusal of the record, it transpires that an F.I.R *vide* Darauli P.S. Case No. 136/2026 was registered on 13.03.2026 u/s 406, 467, 468, 471, 120(B) 420, 120(B) of IPC against the petitioner. As per FIR, the informant is posted as Deputy Superintendent of Police-cum-Assistant investigation officer, he alleged that Mrs. Rita Kumari (petitioner) has appointed as Contractual Panchayat teacher in the year 2007, who has not yet resigned in given stipulated time period prescribed by the Hon'ble High Court, Patna, in the light of Hon'ble Courts order passed in C.W.J. No. 15459/2014 and Investigation no. 08/2015, intermediate educational certificate of contracual teacher Rita Kumari W/o Sanjay Kumar Kushwaha, Village Netwar, P.S.

Darauli, Dist Siwan was sent to Bihar School Intermediate Education Board by District Program Officer (Establishment), Siwan for proper verification. After which they submitted that during the verification of Intermediate marksheet/certificate of the above mentioned employed Panchayat Teacher it was found that the name, father's name, registration number and marksheet given at the time of appointment have been reported to be different and it is completely forged and has not been issued by the Intermediate Education Board, Patna. Thus, Mrs Rita Kumari, a teacher employed by the District Panchayat, colluded with other unknown persons to forge the said marksheet, use the forged marksheet as genuine, and obtain employment illegally under a deliberate criminal conspiracy. .

6. From perusal of record, it appears that petitioner is sole named accused of the FIR and there is allegation against her that she has given forged documents at the time of appointment of panchayat teacher.

7. As per para-3 of the bail petition as well as para-11 of the case diary, it appears that petitioner bears no criminal antecedent. Investigation is still going on.

8. Considering the aforesaid facts and gravity of the offence, the present anticipatory bail application filed on behalf of petitioner **Rita Kumari**, is hereby **rejected**.
