ORDER

1. Learned counsel for the petitioners moves the present anticipatory bail application filed on behalf of the accused-petitioners namely **(1) Shyam Kumar, (2) Sanoj Kumar, (3) Gulab Kumar, (4) Chhotu Kumar@ Chhotelal Mahto, (5) Pankaj Kumar** apprehending their arrest in connection with Daraunda P.S. Case No. 67/2026 registered u/s 126(2), 115(2), 117(2), 118(2), 109, 351(2), 352, 3(5) of BNS, 2023.

2. Learned counsel for the petitioners submits that petitioners are innocent and they have been falsely implicated in this case with an ulterior motive. Learned counsel further submits that no bail application on behalf of the petitioners have ever been filed or pressed either before this learned Court or before the any other Court. The petitioners have no criminal history. There is no chance of their absconding and tampering with the prosecution evidence or the witnesses. Thus, learned counsel prays that petitioners may be granted anticipatory bail.

3. On the other hand, learned P.P vehemently opposed the prayer of bail.

4. Heard. Perused the record.

5. From perusal of the record, it transpires that an F.I.R in this case was registered *vide* Daraunda P.S Case No. 67/2026 dated 09.02.2026 u/s 126(2), 115(2), 117(2), 118(2), 109, 351(2), 352, 3(5) of BNS, 2023 against the petitioners and other co-accused persons. As per F.I.R, the informant alleged that on 08.02.2026, Shyam Kumar was beating the informant's grandson. It is further alleged that when the informant's second grandson tried to intervene, Shyam kumar broke his head by hitting him with an iron bracelet. It is further alleged that on 09.02.2026 all the accused-persons under conspiracy again beat up the informant and his family members with lathi-danda and injured them.

6. From perusal of injury report of Rinkesh Kumar, it transpires that he sustained (i) abrasion on right side of neck size 2" X on skin, (ii) lacerated wound

on front of head size ½" X 1/8" X 1/8", which have opined by the doctor simple in nature. From perusal of Para No. 3 of the bail petition shows that petitioners have clean antecedent, whereas from perusal of Para No. 37 of the case dairy, it appears that petitioners have one criminal antecedent, which was registered after the present case.

7. Considering aforesaid fact, the present anticipatory bail application is **allowed.**

8. It is directed that, in the event of their arrest or surrender before the learned Court below within six weeks from today the petitioners shall be enlarged on bail on furnishing by them bail bonds of Rs. 10,000/- with two sureties of the like amount each, to the satisfaction of the Court below subject to conditions as mentioned under section 482 of B.N.S.S.
