ORDER

14.07.2026

1. Ld. Counsel moves this anticipatory bail petition on behalf of accused petitioner namely **(1) Akhileshwar Tiwari**, who apprehends his arrest in connection with Darauli P.S. Case No. 114/2026 registered u/s 318(4), 338, 351(2), 3(5) of BNS.

2. Ld. Counsel for the petitioner submits that petitioner is innocent and has committed no offence, rather he has falsely been implicated in this case. The allegations as narrated in the FIR is totally false, baseless and concocted. Petitioner bears no criminal antecedent. Ld. Counsel further submits that this false case has been filed only to take retaliation in Title Suit No. 1539/2022 pending in the court of Civil Judge Senior Division-VII, Siwan, which has been filed by this petitioner against the informant of this case and some others. There is land dispute between the parties. There is no chance of his absconding and tampering with the evidence. Hence, Ld. Counsel prays for anticipatory bail.

3. On the other hand, Ld. P.P opposes the prayer for anticipatory bail.

4. Heard. Perused the record.

5. From perusal of the record, it transpires that an F.I.R vide Darauli P.S. Case No. 114/2026 was registered on 02.03.2026 u/s 318(4), 338, 351(2), 3(5) of BNS against the petitioner along with other co-accused persons. As per FIR, the informant alleged that on 13.02.2026, the petitioner along with other co-accused persons have fraudulently registered the informant's land in the name of accused no.2 and 3 by preparing fake document in the Registry Office, Darauli.

6. From perusal of para-3 of the bail petition, it transpires that petitioner disclosed that he bears clean antecedent, whereas from perusal of para-23 of the photo copy of case diary reveals that petitioner has three more criminal antecedents as (i) Guthani P.S Case No. 242/2021 registered u/s 341, 323, 385, 504, 506 of BNS, Guthani P.S Case No. 134/2023

registered u/s 435, 427, 385/34 of BNS and (iii) Guthani P.S Case No. 96/2023 registered u/s 341, 323, 385, 379, 504, 506/34 of BNS. Thus, petitioner Akhileshwar Tiwari actively concealed his three criminal antecedents with intention to mislead this court.

7. Considering the active concealment of three criminal antecedents, the present anticipatory bail application filed on behalf of petitioner **Akhileshwar Tiwari** is hereby **rejected with liberty to file fresh anticipatory bail application disclosing correct detail of criminal antecedent of petitioner.**
