ORDER

09.07.2026

1. The present bail application has been filed on behalf of the accused-petitioner namely **Sujit Kumar Gore**, who is in judicial custody since 10.04.2026 in connection with Darauli P.S. Case No. 160/2026 allegedly instituted for the offences under section 303(2), 317(2), 338 of BNS.

2. Ld. Counsel of the petitioner submits that the petitioner is innocent and has committed no offence rather he has falsely been implicated in this case. Petitioner bears criminal antecedent. Ld. counsel further submits that nothing incriminating article has been recovered either from the person or possession of the petitioner. Petitioner is in judicial custody since 10.04.2026. There is no chance of his absconding or tampering with the prosecution evidence. Hence, Ld. counsel prays for bail.

3. On the other hand, Ld. P.P vehemently opposes the prayer of bail.

4. Heard, perused record.

5. From perusal of record, it transpires that an FIR Vide- Darauli P.S. Case No. 160/2026 was allegedly instituted on 09.04.2026 for the offences under section 303(2), 317(2), 338 of BNS. As per F.I.R, the informant alleged that on 09.04.2026 at about 15:30 O'clock, the informant was to conduct special raid and at about 16:20 O'clock, he was checking vehicle near Narauli More situated at Darauli-Guthani main road and saw that two persons were coming riding on black coloured motorcycle towards Tarnwa Bazaar and on signal of stop, they started fleeing leaving their motorcycle, but with the help of police, they were nabbed and disclosed their name as Mohan Manjhi and Sujeet Kumar Gond. On demand of paper of motorcycle, they did not give any paper of motorcycle.

6. From perusal of record, it appears that petitioner is named accused of the FIR and he was arrested on spot by police with black coloured Hero

Splendor motorcycle. Moreover, Investigation has completed against the petitioner. Petitioner is in judicial custody since 10.04.2026.

7. As per report of S.H.O, Darauli police station, it appears that bears no criminal antecedent.

8. Considering the aforesaid facts and custody period of the petitioner, the present bail application is **allowed**, the petitioner is directed to be released immediately on furnishing bail bonds of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of the court below **with condition that the petitioner shall not repeat such offence in future. If the petitioner is subsequently found indulged in similar offences, the learned trial Court shall take steps for cancellation of his bail bond.**
