ORDER

1. Learned counsel for the petitioner moves present bail application filed on behalf of the accused-petitioner namely **(1) Bhim Kharwar**, who is in judicial custody since 16.05.2026 in connection with Darauli P.S Case No. 115/2026 registered u/s 126(2), 76, 109, 351(2), 61(2) of BNS.

2. Learned counsel of the petitioner submits that the petitioner is innocent and has committed no offence, rather he has falsely been implicated in this case. He further submits that earlier an A.B.P No. 850/2026 was filed on behalf of the petitioner and the same was disposed off and thereafter no any regular bail petition has earlier been filed before this learned Court or the Hon'ble High Court, Patna. The petitioner has got no criminal antecedent. Petitioner is in judicial custody since 16.05.2026. There is no chance of his absconding or tampering with the prosecution evidence. Hence, learned counsel prays for bail.

3. On the other hand, Ld. P.P vehemently opposes the prayer of bail.

4. Heard. Perused the record.

5. From perusal of the record, it transpires that an FIR vide Darauli P.S Case No. 115/2026 was registered on 02.03.2026 u/s 126(2), 76, 109, 351(2), 61(2) of BNS against the petitioner along with other co-accused persons. As per FIR, the informant alleged that during the Vishnu Mahayagya at village-Balia, Riyaz Ansari, Bhim Kharwar, Ravi Kharwar, Akshay Kharwar, Nitesh Yadav and other 5-6 unknown persons misbehaved with women and girls. When the informant protested, all the accused persons committed marpit with him. Thereafter, when the informant had come to Darauli for his necessary work, all the accused persons attacked to informant with iron rod, fighter, gupti and danda, as the result, the informant sustained injury on his hand and shoulder.

6. From perusal of record, it appears that there is allegation against the petitioner that he along with other co-accused persons assaulted the

informant with iron rod, fighter, gupti and danda. From perusal of injury report of injured, it appears Mirunjay Gupta sustained hairline fracture of the vault of skull and doctor opined the nature of injury is grievous caused by hard and blunt substance. As per para No. 3 of the bail petition as well as para No. 38 of the photo copy of case diary, it appears that petitioner bears clean criminal antecedent. Earlier, other co-accused granted bail by this Court vide order dated 25.03.2026 in B.P No. 323/2026. Moreover, petitioner is in judicial custody since 16.05.2026.

7. Considering the aforesaid facts, the present bail application is **allowed**, the petitioner is directed to be released immediately on furnishing bail bonds of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of the Court below.
