ORDER

1. Learned counsel for the petitioner moves present bail application filed on behalf of the accused-petitioner namely **(1) Mantosh Sah@ Mantosh Kumar Sah**, who is in judicial custody since 14.05.2026 in connection with Raghunathpur P.S. Case No. 137/2026 registered u/s 126(2), 115(2), 109, 303(2), 351(2), 352, 3(5) of BNS.

2. Learned counsel for the petitioner submits that petitioner is innocent and he has been falsely implicated in this case with an ulterior motive. Learned counsel further submits that prayer for bail on behalf of this petitioner has never been made or rejected either by this learned Court or by the Hon'ble High Court Patna. The petitioner has got clean past and good antecedents having no criminal history. The accused-person is under custody since 14.05.2026. There is no chance of his absconding or tampering with the prosecution evidence. Thus, learned counsel prays that petitioner may be enlarged on bail.

3. On the other hand, learned P.P vehemently opposed the prayer of bail.

4. Heard. Perused the record.

5. From perusal of the record, it transpires that an F.I.R in this case was registered *vide* Raghunathpur P.S Case No. 137/2026 dated 14.05.2026 u/s 126(2), 115(2), 109, 303(2), 351(2), 352, 3(5) of BNS against accused-petitioner and other co-accused persons. As per F.I.R, the informant alleged that on 13.05.2026 at about 21:10 P.M, informant was at his home, meanwhile informant's pattidars (petitioner along with other co-accused persons) came to his home and started abusing him. On objection, Mantosh Turha attacked informant with an iron rod on his head with intention to kill him, due to which his head got fractured. It is further alleged that informant's wife Pushpa Devi came to rescue, Ritesh Sah beat up the informant's wife and injured her. When his sister-in-law Nirmala Devi came to save them,

Piyush Sah beat up and injured her. It is further alleged that Reena Devi snatched the gold mangalsutra from his wife's neck and ran away.

6. From perusal of injury report of Bharat Sah, it transpires that he sustained (i) Lacerated wound on right side on forehead size 1" inch length and depth 1/8", (ii) Multiple cut mark on head, (iii) Bruise mark on left side of forearm and shoulder, which have been opined by the doctor simple in nature caused by sharp object. From perusal of Para No. 45 of the case diary as well as Para No. 3 of bail petition, it appears that petitioner bears clean criminal antecedent. Moreover, petitioner is in judicial custody since 14.05.2026.

7. Considering aforesaid fact, the present bail application is **allowed**. The petitioner is directed to be released immediately on furnishing bail bonds of Rs. 10,000/- with two sureties of the like amount each to the satisfaction of the Court below.
