ORDER

1. Heard. The Ld. Counsel for the petitioner has submitted that since the case diary is not available and similarly situated co-accused have been granted bail in A.B.P. No. 2698/2024. Therefore, the earlier order of no coercive step may be extended till next date.
2. The Ld. A.P.P. has submitted that he could not obtain the case diary and therefore, one more day may be granted.
3. Heard. From the perusal of record, it appears that earlier vide order dated 30-04-2025 the prosecution has been directed to produce the case diary and order was passed regarding no coercive step against the petitioners.

Let, a copy of this order be communicated to the S.P. Vaishali and S.H.O. Mahua is hereby directed to submit the upto date case diary on next date i.e. 13-06-2025. In the meanwhile, no coercive step shall be taken against the petitioners till next date as they are old persons and female. The S.H.O., Mahua is hereby directed to furnish a show cause as why he has not complied the earlier order of this court. It is relevant to mention that **Hon'ble Supreme Court of India in Satendra Kumar Antil Vs. C.B.I. Case** has fixed a time period for disposal of anticipatory bail application and due to the laxity of the concerned police officials, the bail application could not be disposed of in timely manner. The S.H.O., Mahua is, therefore, directed to produce the up to date case diary before the court on next date and he shall also appear personally to explain the circumstances as why the earlier order dated 13.05.2025 has not been complied. Any failure in this regard will be taken very seriously.

Office Clerk is directed to send the Notice to the complainant at once. The petitioner shall file the requisites of notice at once. Let the hearing of this A.B.P. be put up on 13-06-2025.
