Order

1. The regular bail petition of the petitioner-**Chhotu Kumar**, who is in custody since 14.01.2026 in **Hajipur Town P.S. Case No. 594/2018, U/s – 457, 380, 511 of I.P.C.**

2. The Ld. Advocate on behalf of the petitioner pressed the regular bail petition and submitted that earlier no other bail petition has been moved in this Court or any other superior Court either regular or anticipatory, on behalf of above named petitioner. After cancellation of bail bond, earlier the petitioner granted bail by Hon'ble High Court, Patna in vide Cr. Misc. No. 11662/2019, dt. 05.04.2019. That there is no any criminal bad antecedent against the petitioner. That the petitioner has been in custody since 14.01.2026. That the petitioner was granted bail on 12.04.2018 and cognizance was taken on 27.02.2019. That the petitioner is a poor man and he want to out of state in connection with his livelihood. That the delay is not deliberately rather it is due to lack of knowledge of present situation. That the petitioner undertake to be punctual on future date. That the petitioner is ready to furnish sound and suitable bailors to the satisfaction of the Court.

3. Per contra, Ld. A.P.P. for the State has vehemently opposed prayer for

regular bail.

4. Heard both sides, and perused the L.C.R., and materials available on record, the accused-petitioner is in custody since 14.01.2026., vide order dated 12.04.2019, he filed bail bond and was released, vide order dated 01.03.2023 his bail bond was cancelled. Vide order dated 29.01.2026 charges have already been framed.

5. Hence, in the light of above said, I am inclined to grant privilege of bail to this accused petitioner, the same is hereby, **allowed**. It is ordered that accused-petitioner be enlarged on bail on furnishing of bail bond Rs. 10,000/- (ten thousand) with two sureties of the like amount each to the satisfaction of the ld. Court below.
