ORDER

08.04.2026 The petitioner Rahul Kumar @ Bablu Singh is in custody since
16.09.2025, Ranjeet Kumar Chaudhary @ Golu Chaudhary is in custody since
30.10.2025 whereas Sonu Kumar is in custody since 21.11.2025 in connection with
Jandaha (Mahisaur) PS Case no.-347/2025 and hence the instant petition for the grant
of regular bail has been filed on his behalf. The above named petitioners have filed

the petitions for grant of regular bail in three sets, however, since all the matter relates to the same PS case therefore, for the purpose of convenience the adjudication on the petitions is being made together.

The prosecution case in short as per written application of the informant- Santosh Kumar Singh is that on 15.08.2025 at 07:00PM in the evening, the son of informant of this case namely Shivam Kumar, Aged-22 years was about 500 meters south of his house at a place called Brahma Sthan where preparations were underway for organizing the fair of Shri Krishna, Janmashtami. His son was also present there. Along with him, his uncle, his cousin brother Pintu Kumar was also present. During this time, seven people came there on three motorcycles. Manjeet Kumar Chaudhary, Ranjeet Kumar Chaudhary @ Golu Chaudhary, Ramanand Chaudhary @ Chunni Chaudhary, Sonu Kumar, Ashish Kumar, Manish Kumar, Raja Vishwajeet along with his three other companions were already present at that place, Rahul Kumar @ Bablu Singh, Golu Kumar and 3 other persons who seems to be unknown, whose face was covered with a cloth, all of them surrounded his son Shivam Kumar from all sides and threatened him by showing the pistol, then an altercation started between his son Shivam Kumar and all of them. When his brother Pintu Kumar heard the noise, he ran towards his son. By then Ramanand Chaudhary @ Chunni Chaudhary told all the criminals to shoot the bastard, he is a police informer. Upon hearing this, Ranjit Kumar Chaudhary @ Golu Kumar shot his son in the head and Manjit Kumar shot him in the chest. The further prosecution case is that Ashish Kumar and Sonu Kumar also fired but missed their target and the son of informant fell down and died on the spot. Thereafter all the above named persons fled

away therefrom showing arms. It is further alleged that the main conspirator of this murder is local watchman Santosh Kumar Jha of Village-Madai, PS-Mahisaur, Dist-Vaishali. Accordingly, with the said allegation FIR has been instituted.

Learned counsel for petitioners submitted that the petitioners are innocent and they have committed no offence whatsoever as alleged. It is further submitted that no occurrence have committed as alleged in the FIR and the name of petitioner. It is further submitted on behalf of accused/petitioner Rahul Kumar @ Bablu Singh that petitioner has one criminal antecedent in Patori PS Case no.-18/2020, u/s 395 of IPC. It is further submitted on behalf of accused/petitioner Ranjeet Kumar Chaudhary @ Golu Chaudhary that he has two criminal antecedent in (i) Patori PS Case no. 18/2020, u/s 395 of IPC, (ii) Jandaha PS Case no.122/2019, u/s 448, 341, 323, 324, 307, 379, 504, 506/34 of IPC. It is at last submitted that petitioners are ready to furnish sound bail bond of local bailors to the satisfaction of the court. It is therefore prayed that petitioners be admitted to regular bail.

Learned Additional Public Prosecutor opposed the petition.

Heard the parties and perused the record. On perusal of LCR and Case diary it transpires that the accused/petitioners are named in the FIR and the allegation against them is of committing murder of son of informant along with other co-accused persons. There is direct and specific allegations against them. The informant namely Santosh Kumar in his re-statement in para 7 and other witnesses namely PintuKumar and Ram Naresh Singh in para 8 and 9 of the case diary have supported the prosecution case. The post-mortem report of deceased is mentioned in para 48 of the case diary and attached

separately in which external injury is two bullet entry wounds present with no bullet exit wound and the cause of death is shock and haemorrhage due to fire arm injury. After investigation charge sheet has been submitted by the police against them vide CS no.546/2025 dated 28.12.2025. The allegation against accused/petitioners are heinous in nature. Earlier the regular bail applications of co-accused persons have been rejected by this Court vide B.P. No. 1474 of 2025, BP no. 1735/2025, BP no.1774/2025, BP no.43/2026 and the case of these petitioners stands on similar footings. Hence I am not inclined to admit accused/petitioners on regular bail. Accordingly, the prayers for regular bail of the accused/petitioners is hereby rejected.
