The petitioner above named is in custody since 21.01.2026 in connection with Hajipur Rail PS Case no. 11/2026, u/s 143(5) of BNS, 79 of J.J Act 2015 & 3/14 of Child Labour Act and hence instant petition for the grant of regular bail has been filed on his behalf.

Heard the learned lawyer for the accused/petitioner as well as Learned APP on behalf of state.

The prosecution case as per type report of Rakesh Kumar, Railway Protection force, Hajipur along with other police personal on secret information search Train no.15715 and saw three childre and on inquiry they told that they were being taken away for work in Ajamgar by commission agent Md. Dulal who is also in the same coach who were got identify by the children and he told his name Md. Dulal, Son of Abdul Rashid. The accused Md. Dulal was unboarded from the train and he told that three children are going with him whose name are (i)

Sadiqul Haque, Aged-15 years, (ii) Md. Salim, Aged-13 years, (iii) Barik, Aged-12 years, Son of Suleman Aalam of Ahmedabad, Dist-Katihar. He also told that the children were being taken away for labour work and for the same Rs.10,000/- monthly or Rs. 500/- daily wage is given. The name of the children were confirm by them as said by Md. Dulal. The children were being taken away for work which is a offence. Accordingly, with the said allegation FIR has been instituted.

Learned counsel for petitioner submitted that the petitioner is innocent and he has falsely implicated in this case. It is further submitted that entire prosecution version as alleged is maliciously false and concocted. It is further submitted that police has submitted charge sheet and petitioner is in custody since 21.01.2026. It is therefore prayed that petitioner be admitted to regular bail.

Ld. APP opposed the petition and submitted that the petitioner is named accused in the FIR and there is specific allegation against him of taking away the children from Labha to Azamgarh for doing labour work. Hence his regular bail application is fit to be rejected.

From perusal of LCR and case diary it transpires that petitioner is named accused in the FIR. The allegation against him is of taking away the children from Labha to Azamgarh for doing labour work at Azamgarh.

In the above facts, circumstances and also considering the fact that the allegation against the accused/petitioner is that he was taking away the children from Labha to Azamgarh for doing labour work at Azamgarh and he was been

apprehended. In para 48 of the case diary it has been mentioned that the children were studying in Madarsa and they were scolded and they went away from the madarsa. The parents of children had also filed affidavit to this effect. In this case charge has already been framed on 02.03.2026. As such the accused/petitioner is ordered to be enlarge on bail on furnishing bail bond of Rs 10,000/- with two sureties of the like amount to the satisfaction of the court below.
