Heard the learned defence counsel as well as learned Public Prosecutor on the anticipatory bail application filed on behalf of the above named accused petitioners under section 482 of B.N.S.S. who are apprehending their arrest in connection with Complaint Case No. 646/2022 in which cognizance has been taken for the offences u/ss. 406 & 418 I.P.C..

It is stated in Para 2 of the anticipatory bail petition that no bail application either anticipatory or regular has been filed in the present case either before this court of Sessions or before the Hon'ble High Court, Patna.

The case of the prosecution in brief, as per complaint petition of complainant Sharmila Devi is that on 01.03.2022 at about 10 A.M when she was at her door, then all the accused persons including the petitioners came and co-accused Shivaji @ Manoj Kumar started saying that he got the sale deed executed in the name of his wife, on which what is her objection. The complainant told that the land which he has got the sale deed executed is her ancestral land, out of which the accused Lalmuni Devi and Kiran Devi has executed the excess land of their share in the name of Ful Kumari Devi, which caused loss of Rs.25 lakhs to her. Thereafter altercation between both parties took place. Accused Lalmuni Devi snatched gold

chain from her neck. It is further alleged that Fulkumari Devi has got executed the sale deed with respect to the land of complainant's share by Lalmuni Devi and Kiran Devi.

The learned counsel for the above named accused petitioners submits that the accused petitioners are innocent and have committed no offence. They have falsely been implicated in this case. The entire prosecution case is false and concocted. No occurrence as alleged took place. No Khata, Khesra and area has been mentioned in the complaint petition. The real fact is that a Title Suit No. 413/2021 is pending between the complainant's husband and petitioners. Petitioners have no criminal antecedent. Hence, a prayer has been made to allow this anticipatory bail petition.

The learned Public Prosecutor for the state opposed the prayer for anticipatory bail.

Heard both the parties and perused the trial court record. From perusal of the trial court record, it transpires that cognizance has been taken by the learned trial court for the offences u/ss. 406 & 418 I.P.C. against the petitioners and others. From the complaint petition, it appears that no any Khata number, khesra number of the disputed land has been mentioned in the complaint petition. The co-accused Shivaji @ Manoj Kumar and Fulkumari Devi have already been granted anticipatory bail by this court vide A.B.P. No. 33/2026 and the case of the petitioners stands on the same and similar footing.

Therefore, considering the aforesaid facts and circumstances of the case as well as nature of the allegations, the prayer for anticipatory bail of the above named accused petitioners, are hereby, allowed and it is ordered that in the event of arrest or surrender, they will be enlarged on anticipatory bail, on furnishing bail bonds of Rs.10,000/- with two sureties of the like amount each to the
