<u>20.05.2026</u>	<u>ORDER</u> 1. The Criminal Miscellaneous petition 19 of 2026 filed on behalf of petitioner, namely, Vishal Kumar has been pressed today in connection with A.B.P. No. 1906/2025, U/Ss- 329(3), 126, 352, 75, 351(2), 79, 3(5) B.N.S. & 27 of Arms Act. The Copy of the petition has already been served upon the learned A.P.P. 2. The learned Adv. on behalf of the petitioner Vishal Kumar, filed this petition and submitted that the petitioner was suffering from spinal pain and nephew which treatment have been started Appolo Nurshing Home on 25.08.2025, and he is declared fit by doctor on 14.03.2026 for necking movement. That the petitioner has not availed order pass in A.B.P. No. 1906/25 due to illness is allowed is in fit but the time has been lapsed. That for the ends of justice and seeing is illness of the petitioner it is necessary to extend the period of surendering in A.B.P. No. 1906/25. to fortnight time from the date of passing the order in the present criminal misc.

The learned advocate appearing on behalf of the petitioner Vishal Kumar, who has earlier been granted the privilege of anticipatory bail, Vide A.B.P. No. 1906/25 order dated 26.08.2025 and directed to surrender before the learned Court below within 30 days from the date of order has submitted, but the petitioner became ill and due to this reason he could not surrender within the prescribed time. Thereafter this petitioner is filing the present miscellaneous petition. Considering the fact, I am inclined to allow the Misc. Application and the same is allowed. The time is extended for two weeks from receiving of this order, failing which the liberty shall be cancelled automatically, rest conditions in A.B.P.
