ORDER
(Delivered on this the 14th day of the month of November of the year 2019).

This is an application under Article 248 of Portuguese Civil Registration Code.

2. It is the case of the applicant that he is a Foreign National holding passport bearing no.N658105 valid till 11.05.2020 issued by Portuguese Republic dated 11.05.2015.

3. That the applicant was born in Goa and his place of birth is at Uddo Quelossim, Mormugao, State of Goa, India and had completed his elementary and High School studies from Our Lady of Perpetual Succor High School at Cortalim, Mormugao, Goa, India and is employed at Pertemps in London (U.K.) since 2015.

4. That the applicant is unmarried/bachelor and intends to marry Miss Maria Socorrina Soares, daughter of Baptista Soares and Lurdinha Rosada Misquita, aged about 33 years, spinster, Indian National, r/o H.No.90, Falvaddo, Arossim, Cansaulim, South Goa.

5. That the applicant did not contract marriage earlier either civil or religiously as well as did not promise anyone to marry except to Miss Maria Socorrina Soares and there is no impediment to register their marriage as per the law. That the applicant out of his free will enters into the communion of marriage with his fiancée Miss Maria Socorrina Soares, who or anyone else did not coerced or pressurize him to marry her.

The applicant has produced his affidavit and the affidavits of Miss Maria Socorrina Soares, r/o H.No.90, Arossim, Cansaulim, South, Goa, Mrs. Ana Piedade Lucas, r/o H.No.314, Uddo, Quelossim, Goa, Mrs. Rosamaria Fernandes e Souza, r/o H.No.314, Thana, Cortalim, Mormugao, Goa, Mrs. Lourdinha Rosada Misquita, r/o H.No.90, Falvaddo, Arrossim, Cansaulim, South, Goa, Mrs. Ermelinda Perpetual Fernandes, r/o H.No.90 Falvaddo, Arrossim, Cansaulim, South, Goa and Mr. Sebastiao Soares, r/o H.No.100/D, Borsulim, Cuelim, Cansaulim, South, Goa. The applicant has also produced birth certificates of parties, his passport copies and residence certificate.

7. This Court has also verified the above facts from the witnesses present in the Court and it is revealed that the applicant is a bachelor and Miss Maria Socorrina Soares is a spinster, as also can be seen from the supporting affidavits, in my view there is no legal impediment for the applicant to get married with said Miss Maria Socorrina Soares. Therefore, I am inclined to grant the said application. Hence, the following:

ORDER

The application stands granted. Permission is hereby granted to the applicant to get married to Miss Maria Socorrina Soares and get his marriage registered as prayed for by the applicant. The Civil Registrar of Mormugao, Vasco-da-Gama, Goa to act accordingly.
