ORDER

26.05.2026 The petitioners named above are in custody since 20.04.2026 in connection with Raghobpur PS Case no.-217/2024, u/s 126, 115(2), 118, 117(2), 109, 303(2), 351(2), 352, 3(5) of BNS and hence the instant petition for the grant of regular bail has been filed on their behalf.

The prosecution case in short as per fard-bayan of informant-Mukesh Singh is that some criminal type people of the village, (1) Bablu Singh,(2) Ranjan Singh, with other criminal types people, cut a large amount of soil from informant's land using JCB and tractor. Informant had refused to do so earlier also, but both of them used to abuse him and threaten to kill him. The above mentioned people are criminals against whom many criminal cases are going on. And these people are involved in illegal drug smack, cocaine and arms suppliers. They are criminals in murder cases. Being simple people, informant not able to speak due to fear, but again, due to the above mentioned people digging a large amount of soil from his land, a large lump was formed in informant's

land. Informant told this to some people of the village, on this matter Bablu Singh sent information to informant on 15-07-2024 in the morning and asked him to come to his house. At the said time on 15/07/2024 at around 7-8 p.m. informant reached Bablu Singh's house with his nephew Karan Kamar and saw that (1) Bablu Singh, (2) Ranjan Singh, and both sons of Bablu Singh and 4-5 more people whose names do not know, but informant recognize face, all from Fatepur Police Station Raghopur District Vaishali, on seeing informant, Bablu Singh said kill him right now, he creates ruckus in the village, then Ranjan Singh took out a pistol from his waist and fired aiming at informant but the bullet did not fire, out of fear informant wanted to run away with his nephew to save his life, then Bablu Singh, both sons of Bablu Singh and 4-5 more people with sharp shovel for digging sand and rods and sticks chased and caught both of him and with the intention of Killing them, Bablu Singh attacked on informant with the sharp shovel in his hand. They attacked on his head and while trying to protect his head informant's right hand palm was badly cut. Meanwhile both the sons of Bablu Singh and all the other people attacked on informant with a rod and broke his head badly. They also broke his nephew's head with a rod. One of the four to five unknown persons pulled out the gold chain from informant's neck. Informant and his nephew somehow reached the Chauraha near Kisha Singh's cloth shop, covered in blood and fell down. Meanwhile everyone attacked on informant with great force and made his whole body blue. Meanwhile with the intention of gouging out his eyes, Ranjan Singh attacked both his eyes with the butt of the pistol, injuring both informant's eyes. Meanwhile his nephew, covered in blood, was caught by one of Bablu Singh's sons and he started shouting "call the police". Then

Bablu Singh's son freed himself by cutting informant nephew's shoulder with his teeth, injuring him. Meanwhile Ranjan Singh showing a pistol at him. While shouting he threatened the people standing nearby who were scared and said, bad words if anyone supports him then he will shoot them." And while threatening everyone left. After informing the family members of the victim, nearby people started taking them for treatment. Informant fell unconscious and when he gained consciousness he found myself undergoing treatment at PMCH, Patna, struggling between life and death. Accordingly, with the said allegation FIR has been instituted.

Learned counsel for petitioners submitted that the petitioners are innocent and they have committed no offence whatsoever as alleged. It is further submitted that petitioners have falsely implicated in this case. It is further submitted that present case is counter blast of the petitioner's case and petitioners are man of means and ready to furnish sound and suitable bailors to the satisfaction of the court. It is therefore prayed that petitioners be admitted to regular bail.

Learned Additional Public Prosecutor opposed the petition and submitted that the allegation against accused/petitioners is of assaulting informant and his nephew and caused injury. It is therefore prayed to reject the bail petition of accused/petitioners.

Perused the record. From perusal of LCR and Case diary it transpires that there is allegation of assaulting informant and his nephew and caused injury to them.

In the above facts, circumstances of the case and also considering the fact that the injury report of injured persons Karan Kumar and Mukesh Kumar are given in the case diary provided by P.H.C Raghapur, Vaishali which is simple in nature caused by hard blunt

object like lathi, rod, fist or stone. The accused/petitioners are in custody since 20.04.2026 and there is case and counter case between the parties and the present case is counter blast of Raghapur PS Case no. 241/2024. Hence the accused/petitioners are ordered to be enlarged on regular bail after furnishing bail bond of Rs. 10,000/- each with two sureties of the like amount to the satisfaction of the learned court below.
