The regular bail petition of the above named accused petitioners has been filed u/s 483 of B.N.S.S., who are in judicial custody since 27.04.2026 in connection with Goraul P.S. Case No. 260/2026 for the offences u/ss. 303(2), 318(4), 111(3) & 3(5) of B.N.S..

Heard the learned counsel for the accused petitioners and learned Public Prosecutor for the State as well as learned counsel for the informant and perused the record.

It is stated in Para 2 of the bail petition that no petition for bail either regular or anticipatory has been moved on behalf of the petitioners before this court or before the Hon'ble High Court, Patna.

The case of the prosecution in brief, as per written report of the informant Kunal Kumar Singh is that he is proprietor of Omox Group of Companies. On 25.04.2026 at 8.15 P.M. 3 MT (60 bags) poultry feed was loaded from his company on vehicle no. MH15JC/6499 for Sitamarhi from Hajipur. The names of driver and owner of said vehicle are Sunny Kumar and Bhola Rai and cleaner's name is Vishal Kumar. The said vehicle loaded with poultry feed proceeded for Sitamarhi from Hajipur, which was

embezzled on the way by the said driver, cleaner and owner in a pre-planned manner under conspiracy.

Learned counsel for the petitioners submits that the petitioners are innocent and have committed no offence. The entire prosecution case is false and concocted. They have falsely been implicated in this case. No case u/ss. 393(2), 318(4) & 111(3) of B.N.S. is made out against the petitioners. Moreover, the case has been compromised between the parties. The accused petitioners have no criminal antecedent. Petitioners are in judicial custody since 27.04.2026. Hence, prayer has been made for bail.

Learned Public Prosecutor opposed the prayer for bail.

Heard the parties. Perused the trial court record and the case diary. From perusal of trial court record and case diary it appears that there is general and omnibus allegation against the petitioners to embezzle the poultry feed of the informant which was loaded on their vehicle. Petitioners are owner, driver and cleaner of the vehicle. It further appears that both parties have compromised the case. The certified copy of compromise petition filed in the learned trial court duly signed by informant and petitioners has been annexed with this bail petition, which original compromise petition is available in the trial court record. The informant Kunal Kumar Singh appeared physically before this court with his learned counsel and has supported the factum of compromise and stated that he has received the poultry feed. Petitioners have no criminal antecedent as mentioned in Para 3 of the bail petition and they are in judicial custody since 27.04.2026.

Considering the aforesaid facts and circumstances of the case as well as nature of allegations and the period of custody, the regular bail petition of the petitioners is allowed. Accordingly, the above named accused petitioners are directed to
