ORDER:

1. This order of mine shall dispose off the application for third party objection on behalf of Sh. Ashwani Kumar Mittal objector and praying that the same may kindly be allowed in the interest of justice.
2. On the other hand, the decree-holder in his reply categorically denied the averments made by the decree-holder in the application and hence prayed that the application may kindly be dismissed.
3. I have heard the Ld counsel for the parties and have perused the case file carefully.
4. Perusal of the file reveals that Sh. Gurjot Singh, Revenue Accountant, PSPCL, Sub Division Chawa suffered statement that he has brought the summoned record regarding receipt of payment of Rs.33,67,394/- deposited by Vijay Kumar on 6.4.2023. He has proved the attested copy of said receipt bearing no. 596/58 as Ex.OX. Vijay Kumar s/o Kashmiri Lal has already deposited the decreed amount. Heard. As the JD has already deposited the decretal amount with the decree-holder organization vide receipt Ex.OX on record produced by Sh. Gurjot Singh, Revenue Accountant of decree-holder organization, no useful purpose will be served by attaching the property in question allegedly

belonging to the objector Ashwani Kumar Mittal, therefore the property attached by the court is ordered to be released from attachment and notice regarding the same be issued to concerned revenue authority. In view of the above findings, the present objection petition filed by objector stands disposed off in the interest of justice.
