The accused no. **1. Suresh Pundlik Sultane, 2. Tukaram Rambhau Gawande, 3.Dnyaneshwar Laxman Sutltane and 4. Shankar Dadarao Ingle,** are present before the Court and filed Purnis at **Exh. 2.** they voluntarily pleaded guilty before this court in spite of the consequence of the punishment explained to them in vernacular. I accept their plea being voluntarily and hold them guilty. They prayed for leniency. Hence, taking the circumstances of the case in to consideration and the nature of the offence, I pass the following order.

Order

1] The accused no. **1. Suresh Pundlik Sultane, 2. Tukaram Rambhau Gawande, 3.Dnyaneshwar Laxman Sutltane and 4. Shankar Dadarao Ingle,** are convicted for the offence punishable u/s.12(a) of the Maharashtra Prevention of Gambling Act and they are sentenced to simple imprisonment till rising of the Court and to pay a fine Rs. **300/- each** in words (**Rupees Three Hundred only**) in default to suffer simple imprisonment for 04 days.

2] The muddamal property that is cash of Rs.320/- (Rs. Three Hundred Twenty Rupees only) be credited to Government. Seized 52 playing cards being worthless, be destroyed, after appeal period is over.
