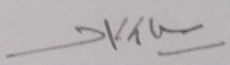
The accused is present before the Court and filed Purnis at **Exh. 2**. He voluntarily pleaded guilty before this court in spite of the consequence of the punishment explained to him in vernacular. I accept his plea being voluntarily and hold him guilty. He prayed for leniency. Hence, taking the circumstances of the case in to consideration and the nature of the offence, I pass the following order.

### Order

1] The accused **Digamber Ishwar Tayade** is convicted for the offence punishable u/s. 12(a) of the Bombay Prevention of Gambling Act and he is sentenced to simple imprisonment till rising of the Court and to pay a fine Rs. **300/-** in words **(Rupees Three Hundred only)** in default to suffer simple imprisonment for 04 days.

2] The muddemal property that is cash of Rs.500/- (Rs. Five hundred only) be credited to Government. Rest of the property i.e. one dot pen, and worli matka chits being worthless, be destroyed, after appeal period is over.
