	11.08.2026	Bail petitioner represented. CD received. I have heard both the sides and also perused the case diary. This is a prayer filed by the petitioner Sankari Dey(u/s 483 BNSS), supported by her sworn statement; praying to enlarge accused Abhisek Dey and Debojit Dey on bail. On 11-07-2026, the informant, Dhanjit Haloi accompanied by SI Mantu Bora and staff of 12th APBn, proceeded to Phuluguri to conduct an enquiry in pursuance to GD Entry No. 06 dated 11-07-2026. During questioning the accused persons and their family members became aggressive and abused the police party and they obstructed the lawful discharge of official duty. Accused Sanjay Kr Dey forcibly caught hold the informant's uniform and pulled it when two buttons got severed. Allegedly the accused persons assaulted the police party, attempted to snatch the service arms of the police personnel

	11.08.2026	and also used criminal force causing serious injury to them. Hence, this Rangapara PS Case No. 48/26 got registered u/s 296/117(2)/109(1)/304(2)/62/132/121(2)/3(5) of BNS. Learned Addl PP N.K. Mishra objected to the bail prayer. Learned engaged Counsel submitted that accused are innocent and they have been arrested on mere suspicion. Perusal of CD, shows that victims sustained simple injury with blunt weapons. There is sufficient progress in investigation. Considering the available material in CD vis a vis progress in investigation, accused Abhisek Dey and Debojit Dey are allowed to go on bail of Rs.30,000/- with two fit sureties, one of whom should be a Government Servant; by each of the like amount to the satisfaction of the learned <i>Elaka</i> Magistrate, on following conditions, in default to go to hazot: i. The accused persons shall not directly or indirectly make any inducement, threat or promise to any
