Q.No.2) : Have you understood the particulars of the offence read over and explained to you in Marathi ?

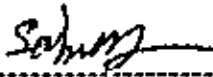

JUDGMENT

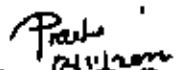
Today accused namely Salman Husain Sayyad is present before the Court. He submitted pursis (Exh.02) on the record and accordingly, he plead guilty. I made him aware about the nature and punishment of offence and consequences of pleading guilty. The plea is voluntary. Considering the nature of offence and the punishment prescribed for the same, I accept the plea of accused.

Heard learned APP and accused on the point of sentence. He submitted that, he is first offence, therefore lenient view may kindly be taken into account while awarding the sentence. In the result, I pass the following order.

ORDER

Accused is hereby convicted for the offence punishable U/ Sec.283 of Indian penal Code, vide Section 252 Cr.P.C. He shall liable to pay fine of Rs.300/- (In words Rupees Three hundred only) in default to suffer simple imprisonment for 5 days.
