1. Report from Incharge, Police Station Sadar, Hoshiarpur has been received and perused. The instant application has been moved by applicant-accused Dalvir Singh son of Gurdeep Singh for grant of interim bail for 3 days or in the alternative, directions to Superintendent, District Jail, Hoshiarpur, to take him to his house for attending marriage of his cousin sister at D.C Road, Hoshiarpur. It is averred that main trial is pending in this Court and applicant-accused is in custody since the inception of this case. It is stated that the applicant has no real sister and his cousin sister Damandeep Kaur is the daughter of his mother's sister whose marriage is going to be performed on 4.12.2022 and function will start on 3rd December, 2022 and 4th December, 2022, where the presence of applicant as a brother is required. The certification of Municipal Councilor alongwith affidavit of Amarjit Kaur wife of Gurdeep Singh are annexed. Prayer has been made for allowing the interim bail to the applicant-accused from 2.12.2022 to 5.12.2022, or in the alternative

he is seeking directions to Superintendent, District Jail, Hoshiarpur, to take him to place of marriage and marriage palace at Tanda Road, Hoshiarpur on 3rd and 4th of December, 2022, in the interest of justice.

2. Arguments heard. There is on record certificate issued by Municipal Councilor, Hoshiarpur verifying the marriage of cousin sister of applicant. Copy of police report has also been perused and police has also verified about marriage of Damandeep Kaur cousin sister of applicant by recording statements of Raghuvir Singh son of Mohinder Singh, neighbourer and Gurdeep Singh father of applicant-accused. So, in view of the facts mentioned in the application and as per certificate of Municipal Councilor, copy of police report and statements of above mentioned persons, the instant application is hereby allowed and the applicant-accused Dalvir Singh son of Gurdeep Singh, resident of D.C. Road, Kali Kambli Wali Gali, Near Aman Hospital, Hoshiarpur, is permitted to attend “*Sri Sukhmani Sahib Path*” on 2.12.2022 and marriage of his cousin sister on 4.12.2022. The Superintendent, Central Jail, Hoshiarpur is directed to depute necessary security guards to take Dalvir Singh for this function, as per rules on 2.12.2022 from 9:00 AM to 4.00 PM and on 4.12.2022 from 9:00 AM to 6.00 PM, at his own expenses. After attending these functions, accused Dalvir Singh be brought back to Jail under necessary security. Necessary intimation be sent to the Superintendent, Central Jail, Hoshiarpur. *Dasti* process can be taken if so desires. Papers be attached with the main trial, pending in this Court.
