This order of mine will dispose of bail application filed by
above named applicants under section 438 of Criminal Procedure Code.

2. Arguments have been heard.

3. Sh. R. S. Bajwa, Advocate, learned counsel for accused/applicants has argued that incharge and other officials of P.S: Sri Hargobindpur are summoning and harassing accused /applicants at the instance of Harwant Singh @ Patto son of Bachan Singh, Dilsher Singh son of Harcharan Singh, Gurinder Singh, Karanbir Singh @ Nav sons of Angrej Singh, Baljeet Singh, Angrej Singh son of Budha Singh, Balkar Singh son of Harnam Singh, residents of village Vithwan, P.S: Sri Hargobindpur, Tehsil Batala, District Gurdaspur. Inspite of repeated requests, Incharge of P.S: Sri Hargobind Pur has not supplied relevant documents or copy of application, so that true facts may come out or accused/applicants may know about allegation imposed against him if any. Accused/applicants are apprehending danger of arrest and unlawful confinement at the hands of local police at any time. Applicants have no concern with complainant with any type of act. Accused/applicants are ready to join investigation as and when required or ordered.

4. Pursuant to notice Shri H. S. Bajwa, learned Additional Public Prosecutor along with SI Joginder Singh No. 2912/Btl P.S. Sri Hargobindpur has put in appearance.

5 SI Joginder Singh has made a statement in court that neither any complaint is pending against accused/applicants Rawail Singh son of Gurbaksh Singh and Balraj Singh son of Rawail Singh in P.S: Sri Hargobidpur nor they are required in any case. Consequently, application in hand is dismissed, having become infructuous, as no blanket order can

be passed.
