2. Whether the respondents No.45 and 46 are entitled to the compensation to the acquired land as per their shares?OPP
3. Whether the present claim petition is not maintainable?OPR
4. Whether the objectors have no locus standi to file and maintain the present petition?OPR
5. Whether the petitioners are estopped by their own act and conduct from filing the present petition?OPR
6. Relief.

No other issue is pressed or claimed by either of the counsel for the parties. Onus not objected to. PF, DM and list of witnesses, if any, be filed within three days. Now, case is adjourned to **16.10.2024** for evidence of petitioners at own responsibility.
